ACT 1936

TAY ROAD BRIDGE

NOTICE is hereby given that application was made on or before 25th March 1989 to the Secretary of State, Scottish Office, Whitehall SW1 by the Tay Road Bridge Joint Board under the provisions of the above Act for a Provisional Order (hereinafter referred to as "the Order") with the above name or short title.

A Notice containing a concise summary of the purposes of the Order has been or will be published in the Dundee Courier newspaper of 31st March and 7th April 1989.

On and after 4th April 1989 a copy of the Order may be inspected and copies thereof obtained at the price of £1 per copy at the undermentioned offices.

Petitions against the order praying to be heard must be deposited at the Scottish Office, Whitehall, London SW1A 2AU not later than 6 weeks after 11th April 1989 in the manner and subject to the conditions prescribed in General Orders 75 to 77 copies of which may be inspected at the offices mentioned in the immediately preceding
