CLEARANCE OF UHF FREQUENCY BAND OF FIXED LINKS AND SCANNING TELEMETRY LINKS NOTICE OF VARIATION AND REVOCATION

SCANNING TELEMETRY LINK LICENCES

(including any letter of authority to operate a scanning telemetry link) that, with effect from 1st January 1990 -

- (a) such licences which authorise the establishment or installation, and use, of any scanning telemetry link in the 450-470 MHz frequency band are hereby varied with the effect that only those scanning telemetry links operating on frequencies within the sub-band 457.5/458.5 MHz to 463/ 464 MHz are authorised, and the establishment, installation and use of any scanning telemetry link that does not satisfy the above condition shall no longer be authorised; and
- (b) such licences which authorise only the establishment or installation or use of scanning telemetry links which do not satisfy the above condition are hereby revoked.

ADVICE

Licensees using such links should have received notification of this variation or revocation, advising them that the links should be

abandoned with all due haste and in any case by 31st December 1989 at the latest. The Department of Trade and Industry is endeavouring where desired to assign new frequencies in place of the ones withdrawn.

Licensees are warned that continued use of the links which are no longer authorised on or after 1st January 1990 will be a contravention of the terms, provisions and limitations of any varied licence, and, whether the licence has been varied or revoked, of section 1 of the Wireless Telegraphy Act 1949. Any licensees who fail to relinquish those links by 31st December 1989 risk criminal proceedings and/or the immediate revocation of their licences.

FAIR TRADING ACT 1973 MONOPOLY REFERENCE PLASTERBOARD

THE Director General of Fair Trading in exercise of his powers under sections 47(1), 49(1) and 50(1) of the Fair Trading Act 1973 ('the Act'), hereby refers to the Monopolies and Mergers Commission the matter of the existence or possible existence of a monopoly situation in relation to the supply within the United Kingdom of plasterboard.

The Commission shall investigate and report on the questions whether a monopoly situation exists in relation to such supply and; if so:

- (d) whether any action or omission on the part of that person or those persons is attributable to the existence of the monopoly situation and, if so, what action or omission and in what way it is so attributable; and

(e) whether any facts found by the Commission in pursuance of their investigations under the preceding provisions of this paragraph operate, or may be expected to operate, against the public interest.

The Commission shall report on this reference within a period ending on 31st July 1990.
