GRAMPIAN REGIONAL COUNCIL

STATION ROAD AREA, DYCE

THE Grampian Regional Council proposes to make The Grampian Regional Council (Station Road Area, Dyce) (Prohibition Of Waiting) Order, 19 under Sections 1(1) and (2) and 2(1) and (2) of the Road Traffic Regulation Act 1984.

The effect of the order will be to regulate waiting of vehicles on the specified lengths of roads listed in the Schedule to this order.

Exemptions will permit waiting:-

- (1) for the purposes of picking up or setting down passengers;
- (2) for the purposes of loading or unloading goods;
- (3) where necessary in connection with any building operation or demolition; the removal of any obstruction to traffic; the maintenance of roads for the supply of gas, electricity, water or telegraphic services;
