THE Social Security Advisory Committee gives notice that it has been asked by the Secretary of State for Social Security under Section 10 of the Social Security Act 1980 to consider and report on the draft of regulations entitled THE STATUTORY SICK PAY (RATE OF PAYMENT) REGULATIONS 1989 to amend the statutory sick pay scheme.

A short explanatory note provided by the Department of Social Security on these regulations is appended to this notice. The Committee will consider representations on the subject received not later than 29 December 1989. These should be addressed to Mr N Cockett, the Secretary, Social Security Advisory Committee, Room 458, New Court, Carey Street, London WC2A 2LS from whom a note setting out the statutory sick pay changes may be obtained. Representations will be accepted from Northern Ireland where similar provisions will be introduced.

## Explanatory Note

Statutory sick pay is payable at on of two rates depending on the person's earnings. At present the lower rate of SSP is payable for earnings between £43 and £83.99 a week, and the higher rate for earnings above £84 a week. The Secretary of State is required to review each year the rate of SSP. The Regulations put into effect the results of that review. They provide for increases in the two rates of SSP and in the earnings band at which the higher rate becomes payable. The proposed changes will come into effect on 6 April 1990.


