### COPYRIGHT, DESIGNS AND PATENTS ACT 1988 COPYRIGHT TRIBUNAL

NOTICE is hereby given, pursuant to Rule 5 of the Copyright Tribunal Rules 1989, of a reference under Section 118 of the Copyright, Designs and Patents Act 1988 by the British Phonographic Industry Limited of Roxburghe House, 273/287 Regent Street, London W1R 7PB (hereinafter called "the Applicant").

A copy of the Notice of Reference together with a copy of the Applicant's Statement of Case was served on the Mechanical-Copyright Protection Society Limited of Elgar House, 41 Streatham High Road, London SW16 1ER (hereinafter referred to as "the Licensing Body") on 11 June 1990.

The dispute relates to a proposed Licensing Scheme ("the Proposed Scheme") to be operated by the Licensing Body for record companies requiring licences in respect of mechanical recording and circulation rights for the production and sale of commercial recordings. The said dispute relates to

(a) the rate of the mechanical recording and circulation rights royalties to be paid by record companies to music publishers and/or music composers under the Proposed Scheme; and/or

(b) the scope of the licences granted under the Proposed Scheme;

(c) the criteria for determining which standard form agreement a particular record company enters into under the proposed Scheme and the extent of the differences between the standard forms;

(d) the procedure to be adopted for the administration of the Proposed Scheme.

### SEA FISH INDUSTRY AUTHORITY FISHERIES ACT 1981

#### NOTICE OF LEVY REGULATIONS

1. The Sea Fish Industry Authority hereby give notice that, in exercise of their powers under the above Act, it is their intention to make amendement regulations which, subject to their confirmation by order of Ministers, will increase the levy to 0.918p per kilogram in respect of sea fish landed in the United Kingdom or trans-shipped within British fishery limits and proportionate levies in respect of sea fish products so landed or trans-shipped with the exception that reduced levies will be prescribed for pelagic fish, fishmeal production, imported sea fish.

2. The draft regulations can be inspected between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays inclusive at the office of the Sea Fish Industry Authority at Sea Fisheries House, 10 Young Street, Edinburgh EH2 4JQ,or at any of the local offices of the Authority at Aberdeen, Bangor, Co. Down, Hull, London and Plymouth.

3. Copies of the draft regulations can be purchased from the Sea Fish Industry Authority, at the address given below, at a cost of 30p per copy, post free.

4. The Authority are prepared to receive and consider any objections to the proposed amendment regulations. Any such objections should be in writing and should be sent to the Authority at
