NOTICE

TREASURY MINUTE dated 27th November 1990

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 28th November 1990 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the

loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;

- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);

BORDERS REGIONAL COUNCIL (VARIOUS STREETS, GALASHIELS) (REGULATION OF TRAFFIC) (AMENDMENT) ORDER 1990

NOTICE is hereby given that The Borders Regional Council intend to make the above Traffic Order in exercise of the powers conferred on them by Sections 1 and 2 of the Road Traffic Regulation Act 1984 and in exercise of all other powers enabling them in that behalf, and after consultation with the Chief Constable of Police in accordance with Part III of Schedule 9 of the said Act, and with the Secretary of State.

The effect of the Order will be to vary the Traffic Order made in April 1990 so that:—

- (1) Vehicles will be prohibited or restricted from waiting, loading or unloading in additional lengths of Bank Street, Green Street, High Street, Ladhope Vale, Magdala Terrace, Paton Street, Roxburgh Street and Union Street. Vehicles will also be prohibited from waiting at any time in Elm Row between its junction with Lawyers Brae and a point 35m south of that junction.
- (2) Union Street shall be "one-way" from Roxburgh Street to Hall Street. The northern end of Roxburgh Street will cease to be one-way.
- (3) All vehicles with the exception of public service vehicles and certain other vehicles will be prohibited from driving along that part of Channel Street between High Street and Park Street.

Full details of these proposals are in the draft Order which together with maps showing the restricted lengths of road and a Statement of the Council's reasons for proposing to make the Order may be examined at the Roads and Transportation Department, Borders Regional Council, Regional Headquarters, Newtown St. Boswells from Monday to Thursday between the hours of 9 a.m. and 4 p.m. and on Fridays between the hours of 9 a.m. and 3 p.m. and also at Galashiels Public Library during the hours of opening.

FORT AUGUSTUS CONSERVATION AREA

NOTICE is hereby given that Highland Regional Council, in exercise of the powers conferred upon them by Section 262 of the Town and Country Planning (Scotland) Act 1972, as amended (hereinafter referred to as "the Act") have designated part of Fort Augustus as a conservation area.

Where any area is for the time being designated as a conservation area, special attention shall be paid to the desirability of preserving or enhancing its character or appearance in the exercise, with respect to any buildings or other land in that area, of any powers under the Act, part I of the Historic Buildings and Ancient Monuments Act 1953 or the Local Authorities (Historic Buildings) Act 1962.

In terms of Section 262A of the Act, subject to the provisions of that Section, any building in a conservation area (other than those excepted by the said Section 262(a)) shall not be demolished without the consent of the Regional Council or the Secretary of State. In addition, Sections 53, 54(3), (4), (5) and (6), 54A, 54B, 92 to 95, 161, 179, 253(1)(b), Parts I and II of Schedule 10 and Schedule 17, of the Act shall have the effect in relation to buildings to which the said Section 262A applies as they have effect in relation to listed buildings.

In terms of Section 59A of the Act, subject to the provisions of that Section, any person who, in relation to a tree in a conservation area which is not the subject of a Tree Preservation Order, does any act which might by virtue of Section 58(1)(a) of the Act be prohibited by a Tree Preservation Order shall be guilty of an offence. Sub-section 8 of the said Section 59A also provides that if any tree to which the said Section 59A applies, is removed, uprooted or destroyed in contravention of that Section, or is removed, uprooted or destroyed or dies at a time when its uprooted or felling is authorised only by virtue of the provisions of any Regulation made by the Secretary of State, it shall be the duty of the owner of the land unless on his application the Regional Council dispense with this requirement, to plant another tree of an appropriate size and species at the same place.

The extent of the conservation area is set out in the Schedule hereto. A plan showing the extent of the conservation area may be inspected at the Department of Planning, Regional Buildings, Glenurquhart Road, Inverness, between the hours of 9.00 a.m. and 5.00 p.m. on Mondays to Fridays inclusive.

The designation of the above mentioned conservation area will take effect from the date of the publication of this Notice.
