

- (a) picking up and setting down of passengers;
 - (b) where necessary, permit waiting, in connection with the maintenance of the roads or adjacent buildings and services;
 - (c) where necessary, permit waiting, in pursuance of statutory powers and duties; and
 - (d) vehicles waiting to be weighed at the weighbridge.
4. Full details of these proposals are in the Draft Order which, together with the map showing the restricted lengths of road and a statement of the Council's reasons for proposing to make the Order, may be examined at the Council Offices, Sandwick Road, Stornoway between the hours of 9 am and 5 pm on Mondays to Fridays.
 5. The Order is being made to enable the access to Number 2 Pier and the weighbridge to be kept clear for discharges and weighing operations and to ensure that the access to Cromwell Street Quay is kept free at all times for use in an emergency.
 6. Any person wishing to object to the Proposed Order should send details of the grounds for objection in writing to the Director of Administration and Legal Services, Council Offices, Sandwick Road, Stornoway within 21 days of the date of publication of this Notice.
