NOTICE is hereby given by Dumfries and Galloway Regional Council under Schedule 5 to the Water (Scotland) Act 1980 that the Regional Council have applied to the Secretary of State for Scotland for an order under section 77 of that Act which will authorise them to take water from Lochnaw Castle Lochs (White Loch and Black Loch) to augment supplies to Dindinnie Reservoir.

Because of a period of exceptional shortage of rain the level of the reservoirs at Dindinnie and Knockquhassen in the Wigtown District of the Region has reached a point where a serious deficiency of supplies of water is threatened. The authorisation sought is to take not more than 1500 cubic metres of water per day from Lochnaw Castle Lochs (White Loch and Black Loch).

Authority is also sought under the Order to permit the laying of a temporary pipeline overland from Lochnaw Castle Lochs to Dindinnie Reservoir for the purpose of pumping water taken from the Lochs into the Reservoir.

The authorisation is sought for a period not exceeding 6 months.

A Plan showing the location of the lochs, reservoir and pipeline will be available at the Water & Sewerage Department, Sun Street, Stranraer for inspection by any person free of charge at all reasonable hours within the period of seven days from the date of publication of this notice.

Objections to the application may be made to the Secretary of State for Scotland, 27 Perth Street, Edinburgh within the period of seven days from the date of publication of this notice.
