(PROHIBITION OF WAITING) ORDER 1991

THE Central Regional Council made the above named Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 at their Meeting on 11th September 1991.

The Order will prohibit waiting at any time on the sections of roads as detailed in the Schedule hereto.

A copy of the Order, together with a copy of the relative plan, may be examined at the Regional Council's Offices, Viewforth, Stirling (Room 19) and at Falkirk District Council's Offices, Municipal Buildings, Falkirk (within the Administration Department's Enquiry Office) during normal office hours free of charge.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that any requirement therein has not been complied with, may, within six weeks from 11th September 1991, apply to the Court of Session for this purpose.

Roads in Torwood	Side and Section of Road on Which Waiting is Prohibited At Any Time.
A.9 Torwood NO WAITING AT ANY TIME	On both sides thereof from a point 60 metres or thereby south of the southern entrance/exit of the garden centre, northwards for a distance of 210 metres or thereby.
Castle Crescent, Torwood NO WAITING AT ANY TIME	On both sides thereof from its junction with A.9, westwards for a distance of 10 metres or thereby.

**THE CENTRAL REGION (STATION ROAD, QUAKERFIELD,
 NEWMARKET AND GREENACRE PLACE, BANNOCKBURN)**
(PROHIBITION OF WAITING) ORDER 1991

SCHEDULE

Roads in Bannockburn	Side and Section of Road on Which Waiting is Prohibited At Any Time.
Station Road	(a) On the west side thereof from its junction with Quakerfield in a northerly direction for a distance of 58 metres or thereby. (b) On the east side thereof from its junction with Quakerfield in a northerly direction for a distance of 36 metres or thereby.
Quakerfield	(a) On the north side thereof from its junction with Station Road in an easterly direction for a distance of 29 metres or thereby. (b) On the north side thereof from its junction with Station Road in a westerly direction for a distance of 9 metres or thereby.
Greenacre Place	(a) On the west side thereof from its junction with Quakerfield in a southerly direction for a distance of 16 metres or thereby. (b) On the east side thereof from its junction with Quakerfield in a southerly direction for a distance of 14 metres or thereby.
Newmarket	(a) On the north side thereof from a point opposite the west boundary of No. 35 Newmarket, in an easterly direction to the west boundary of Stein Square, a distance of 82 metres or thereby. (b) On the south side thereof from a point opposite the west boundary of Stein Square in a westerly direction for a distance of 25 metres or thereby.

Side and Section of Road, on Which Waiting is Prohibited between 8 am and 6 pm Monday to Saturday inclusive.

Quakerfield	On the north side thereof from a point 9 metres east of the east kerbline of Station Road in an easterly direction for a distance of 30 metres or thereby.
