The authorised fuels area anthracite and semi anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuel, low volatile steam coals, fluidised char binderless briquettes manufactured by Coal Products Limited, Authracine N20, Anthramer, Antrex, Clean Flame, Fireglo, Phurnacite, Pure Heat, Sovereign, Supertherm, Thermac, Thermaglow, Thermobrite, Ancit 40 and Ancit 60 Briquettes.

Copies of the Order (and of the Map referred to therein) may be inspected free of charge at the office of the Director of Environmental Health, Environmental Health Department, Johnston Terrace, Edinburgh EH1 2PT at all reasonable times during the six week period from the first day of October 1991.

Within that period any person who will be affected by the Order may object to its confirmation by writing to the Director of Administration, City of Edinburgh District Council, City Chambers, High Street, Edinburgh EH1 IYJ.
