ORDER 1991

The City of Glasgow District Council hereby gives notice that it has made an Order under Section 198A and 199 of the Town and Country Planning (Scotland) Act 1972, authorising the stopping up of:

1. Unnamed roads and footpaths between Roystonhill and James Nisbet Street.

A copy of the Order and relevant plan specifying the length of roads and footpaths to be stopped up may be inspected at the Planning Department, 231 George Street, Glasgow G1 1RX, by any person, free of charge, at all reasonable hours, during a period of 28 days from the date of publication of this notice. Within that period any person may, by notice to the Planning Department at the above address, object to the making of the Order. If no representations or objections are duly made, or if any so made are withdrawn, the Order may be confirmed by the District Council as an unopposed Order.
