THE Central Regional Council made the above named Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 at their Meeting on 30th October 1991.

The Order will prohibit waiting on those sides and sections of Haugh Street, Bainsford detailed in the Schedule hereto.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that any requirement therein has not been complied with, may, within six weeks from 30th October 1991, apply to the Court of Session for this purpose.
