#### OFFICE OF ELECTRICITY REGULATION NOTICE UNDER SECTION 11(2) OF THE ELECTRICITY ACT 1989

THE Director General of Electricity Supply (hereinafter referred to as "the Director"), pursuant to Section 11(2) of the Electricity Act 1989 (c.29) (hereinafter referred to as "the Act") hereby gives notice as follows:

(1) He proposes to make a modification to the licences which have been granted under section 8(1) of the Act to Scottish Power plc and Scottish Hydro-Electric plc by the addition of a new Condition 4 in Part VI of the licences to the effect set out in the Schedule hereto, together with the necessary consequential modifications specified in the Schedule.

- (2) The reason why he proposes to make the modifications is to effect the changes to the licence which are necessary to satisfy the obligations to implement those requirements of the European Council Directive dated 29th October 1990 (90/547/EEC) on the transit of electricity through transmission grids which are not already imposed on the licensee under the existing conditions of the transmission licence.

- A In Part VI of the Licence Document of Scottish Power plc insert: Condition 4 Requests for Transit
- 1. In this Condition:

"entity" means any of the entities referred to Article 3.1 of the Directive of the Council of the European Communities, dated 29th October 1990 (No. 90/547/EEC), on the transit of electricity through transmission grids ("the Directive");

"grid" means any high-voltage electricity transmission grid for the time being listed in the Annex to the Directive;

"Member State" means a Member State of the European Communities;

"transit" means a transaction for the transport of electricity between grids where —

- the grid of origin or final destination is situated in a Member State; and
- (b) the transport involves
  - the crossing of at least one frontier between Member States; and
  - (ii) the use of the licensee's transmission system and at least two other grids.
- The licensee shall, after receiving in connection with transit for a minium duration of one year an application by any entity for an agreement for —
  - (a) use of system;
  - (b) connection to the licensee's transmission system or modification to an existing connection; or
  - (c) use of the Scottish Interconnection,

notify the Secretary of State, the Director and the Commission of the European Communities without delay of the matters set out in paragraph 3 below.

- 3. The matters of which notification must be given are:
  - (a) the application;
  - (b) if an agreement has not been concluded within 12 months of the date of receipt of the application, the reasons for the failure to conclude it;
  - (c) the conclusion of the agreement, whether it is concluded before or after the expiry of the period mentioned in subparagraph (b) above.
- 4. If, in relation to an application for transit by any entity, the Director has been requested to exercise his powers under Condition 2C or 3C, the Director may delay the exercise of his said powers until the terms have been considered by the body set up under Article 3.4 of the Directive and the Director may give such weight to the opinion (if any) of that body as he thinks fit in exercising his said powers."

- B In paragraph 13 of Condition 3 of Part IV of the Licence Document of Scottish Power plc after "Conditions 3A to 3C" insert "and 4".
- C In Part VI of the Licence Document of Scottish Hydro-Electric plc insert the new Condition set out in paragraph A above except that sub-paragraph 2(c) of that Condition shall read —

"(c) use of the licensee's share of the Scottish interconnection,"

- D In paragraph 14 of Condition 3 of Part VI of the Licence Document of Scottish Hydro-Electric plc after "Conditions 3A to 3C" insert "and 4".

#### TREASURY MINUTE dated 5th November 1991

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 6th November 1991 and until the coming into operation of a further determination:

 The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 am two banking days before credit day; II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);

### THE DENNYLOANHEAD-KINROSS TRUNK ROAD (A977) (CROOK OF DEVEN) (RESTRICTED ROAD) ORDER 199

THE Secretary of State gives notice that he proposes to make the above Order imposing a 30 mph speed limit on that length of the Dennyloanhead-Kinross Trunk Road (A977) at Crook of Devon in Tayside Region from a point 275 metres or thereby south west of the Manse access road to a point 100 metres or thereby north east of the junction with Station Road.
