Sections 20(4) and (5) of the Gas Act 1986 provide that the Director General of Gas Supply may give directions as to the capacity of a proposed pipeline and as to the cost of its construction, if satisfied in the light of representations;

- a) that a demand exists or is likely to arise for the conveyance of gas, or of a kind similar to, the kind specified in the notice relating to a proposed pipeline; and
- b) that the routes along which the gas will require to be conveyed will severally be, as to the whole or any part thereof, the same or substantially the same as the route or any part of the route so specified.

Any representations as to such matters should be made in writing and delivered to the Director General of Gas Supply, Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT in such manner that:

- a) an indication in respect of the gas for the conveyance of which a demand may exist or be likely to arise, of
 - (i) its origin
 - (ii) its quantity; and
 - (iii) the rate at which it may be conveyed,
 is delivered within 28 days of publication of this notice; and
- b) any other and further representations are delivered within 90 days of publication.
