(VARIATION NO. 1) ORDER 199 TO 702

THE Lothian Regional Council in exercise of their powers under Sections 1(1), 2(1), (2), 32(1), 35(1) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, propose to make an Order the effect of which will be to introduce a Residents' Parking Scheme in Haddington Town Centre, to exempt residents' vehicles from the time limit on duration of stay at on-street parking places and where there are limited waiting controls, by varying The Lothian Regional Council (Various Streets, Haddington) (Traffic Regulation; Prohibition and Restriction of Waiting, and Parking Places) Order 1984. The proposed Order will also vary The Burgh of Haddington (Lodge Street) (Restrictions on Driving) Order 1963 to enable vehicles to deliver to the residential and shop premises which front the closed length of Lodge Street.
