RATES OF INTEREST ON LOANS BY THE PUBLIC WORKS LOAN COMMISSIONERS TO LOCAL AUTHORITIES

NOTICE

TREASURY MINUTE dated 17th March 1992

The Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 18th March 1992 and until the coming into operation of a further determination:

- I The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 am two banking days before credit day;
- II Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);

PWLB Non-quota A Rate loans will bear interest at 1 per cent above the corresponding Quota rates.

PWLB Non-quota B Rate loans will bear interest at 2 per cent

above the corresponding Quota rates.

The amount which a local authority borrows within its annual quota will bear interest at the appropriate rate in the quota set of rates. Authorities may borrow further sums at quota rates at the discretion of the Public Works Loan Commissioners. Other borrowing beyond the quota entitlement will be at the appropriate rate in the non-quota set of rates.

My Lords concur

SUSPENSION OF DIRECTION PROHIBITING EXERCISE OF POWERS IN RELATION TO CONTROLLED DRUGS

DOCTOR DEREK WARDALE

IN accordance with Section 12(4) of the Misuse of Drugs Act 1971, notice is hereby given that the Secretary of State has given the following direction which came into force on 19th February 1992:

THE TRUNK ROADS (40 MPH SPEED LIMIT) (CUPAR) ORDER 199 AND THE TRUNK ROADS (RESTRICTED ROADS) (FIFE REGION) (AMENDMENT) ORDER 199

THE Secretary of State gives notices that he proposes to make the above orders:

- (1) Revoking the Trunk Roads (40mph speed limit) (Cupar) Order 1981 and replacing it with a similar order imposing a 40mph speed limit on the following length of trunk road: That length of the Kincardine-Cupar-St Andrew's Trunk Road (A91) at Cupar in Fife Region known as Carslogie Road from a point 422 metres or thereby west of the centre line of West Park Road westwards for a distance of 306 metres or thereby.
- (2) The schedule to the Trunk Roads (Restricted Roads) (Fife Region) Order 1976 will be amended so that the following

paragraphs will now read;

"6. That length of the Kincardine-Cupar Trunk Road (Route A91) at Auchtermuchty in Fife Region from a point 31 metres or thereby west of the junction with high road to a point 198 metres or thereby east of the east kerbline of Middleflat a distance 1360 metres or thereby".

"7. That length of the Kincardine-Cupar Trunk Road (Route A91) at Cupar in Fife Region from a point 422 metres or thereby west of the centre line of West Park Road to a point 224 metres or thereby east of the centre line of Bowling Green Road, a distance of 1508 metres or thereby.

Full details of the proposal are contained in the Orders, which together with plans showing the lengths of road involved, Orders to be revoked, and a statement of the Secretary of State's reasons for proposing to make the orders may be examined during normal office hours at:

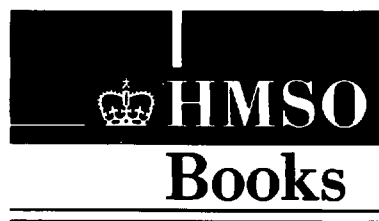
