(TEMPORARY RESTRICTION OF TRAFFIC, TEMPORARY
 PROHIBITION OF OVERTAKING AND TEMPORARY
 40MPH SPEED LIMIT) ORDER 1992

THE Secretary of State hereby gives notice that he has made the above order temporarily restricting traffic, prohibiting overtaking, and imposing a 40mph speed limit on the following length of trunk road:-

The Edinburgh-Berwick Upon Tweed Trunk Road (A1)

That length of the Edinburgh-Berwick Upon Tweed Trunk Road (A1) in Borders Region from a point where it meets the National Boundary between Scotland and England, being 370 metres or thereby south of the south east corner of No 1 Lamberton Holding, in a generally northerly direction for a distance of 1.5 kilometres or thereby to a point 510 metres or thereby north of the north corner of No 16 Lamerton Holding.

This Order is required for road safety reasons during ongoing roadworks on the length of trunk road described above for the period from 3rd August 1992 until 2nd August 1993. The restrictions will apply only where indicated by the appropriate traffic signs.

THE Secretary of State hereby given notice that he has made the above order temporarily restricting traffic, temporarily prohibiting overtaking, and temporarily imposing a 40mph speed limit on the following length of trunk road:-

That length of the Kirkcaldy-Melville Gates Trunk Road (A92) in Fife Region from a point 100 metres or thereby south of the overbridge at Blackwood Road for a distance of 2.54 kilometres or thereby to Preston Roundabout, both northbound and southbound.
