THE STRATHCLYDE REGIONAL COUNCIL, in exercise of the powers conferred on them under the Flood Prevention (Scotland) Act, 1961, propose to carry out flood prevention operations the purpose of which is to mitigate the flooding of the Pollok area of Glasgow from the Brock Burn and Lavern Water. For that purpose, the Regional Council on 4th July 1991 made a Scheme under Section 4 of the 1961 Act, known as the Strathclyde Regional Council (Brock Burn and Lavern Water) Flood Prevention Scheme 1991, and that Scheme was confirmed without modification by the Secretary of State for Scotland on 15th September 1992. The proposed operations consist generally of the construction of flood banks and flood walls and other ancillary works along various stretches of the Brock Burn and Lavern Water. Details of the proposed operations are as listed in the Scheme and as shown on the plans annexed and executed as relative thereto.
