(PROHIBITION OF WAITING) (AMENDMENT) ORDER 1992

THE CENTRAL REGIONAL COUNCIL made the above named Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 at their Meeting on 28th October, 1992.

The Order will extend the existing "No Waiting" restrictions on Old Earl's Road, Grangemouth as detailed in the Schedule.

A copy of the Order, together with a copy of the relative plan, may be examined at the Regional Council's Offices, Viewforth, Stirling (Room 19) and at Falkirk District Council's offices (within the Admin. Department's Enquiry Office), Municipal Buildings, Falkirk during normal office hours free of charge.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that any requirement therein has not been complied with, may, within six weeks from 28th October, 1992 apply to the Court of Session for this purpose.

Road In Grangemouth

*Sides and Sections of Road on which  
Waiting is Prohibited At Any Time*

Old Earl's Road

On the west side thereof from a point 305 metres or thereby southwest of its junction with the roundabout at the junction of Earl's Road, Old Earl's Road, Station Road and South Bridge Street for a distance of 83 metres or thereby in a southerly direction.

On the east side thereof from a point 305 metres or thereby south west of its junction with the roundabout at the junction of Earl's Road, Old Earl's Road, Station Road and South Bridge Street for a distance of 20 metres or thereby.

On the east side thereof from a point 330 metres or thereby south west of its junction with the roundabout at the junction of Earl's Road, Old Earl's Road, Station Road and South Bridge Street for a distance of 20 metres or thereby in a southerly direction.

(REVOCATION AND AMENDMENT)

ORDER 1992

THE CENTRAL REGIONAL COUNCIL made the above named Order under Sections 1(1) and (2), 2(1) to (3), and 4(2) and Part IV

of Schedule 9 of the Road Traffic Regulation Act 1984 at their Meeting on 28th October, 1992.

The Order will prohibit waiting at any time on the sides and sections of roads detailed in Schedule I and between the hours of 8.00 a.m. and 6.00 p.m. Monday to Saturday inclusive on the sides and sections of roads detailed in Schedule II.

A copy of the Order, together with a copy of the relative plan, may be examined at the Regional Council's Offices, Viewforth, Stirling (Room 19) and at Stirling District Council's Offices, Municipal Buildings, Corn Exchange Road, Stirling during normal office hours free of charge.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that any requirement therein has not been complied with, may, within six weeks from 28th October, 1992 apply to the Court of Session for this purpose.

SCHEDULE I

Road In Killin

*Side and Section of Road on Which  
Waiting is Prohibited at any Time*

Dochart Road/Gray Street

On the north side thereof:-

From the 30 mph sign situated approximately 55 metres west of the west wall of the War Memorial in an easterly direction for a distance of 173 metres or thereby to the west boundary of the lay-by

From the east boundary of the lay-by in an easterly direction to a point opposite No. 5 Gray Street, a distance of approximately 48 metres.

On the south side thereof:

From the 30 mph sign situated approximately 55 metres or thereby west of the west wall of the War Memorial in an easterly direction to the west kerb line of the access to Rowan Bank and Eilean Cor, Dochart Road, a distance of approximately 104 metres.

SCHEDULE II

Road In Killin

*Side and Section of Road on Which  
Waiting is Prohibited between the  
hours of 8.00 a.m. and 6.00 p.m.  
Monday to Saturday (Inclusive)*

Dochart Road/Gray Street

On the south side thereof from the east kerbline of the access road to Rowan Bank and Eilean Cor, in an easterly direction to point outside the west boundary of No. 5 Gray Street, a distance of 150 metres or thereby.
