(GLENIFFER ROAD AND CAMPSIE DRIVE, RENFREW)
(PROHIBITION OF ENTRY) ORDER 1992

ON Thursday, 19th November 1992 the Regional Council made the above-named Order in terms of the Road Traffic Regulation Act 1984.

The Order which comes into operation on Monday, 23rd November, 1992 closes

- (a) Gleniffer Road, Renfrew, except for emergency service vehicles, at its junction with Paisley Road; and
- (b) Campsie Drive, Renfrew, between Numbers 21 and 23 and adjacent to Number 23.
