MONTROSE HARBOUR REVISION ORDER

NOTICE is hereby given that the Montrose Port Authority (thereinafter called "the Authority") have applied to the Secretary of State for Transport to make a Harbour Revision Order under section 14 of the Harbours Act 1964.

The objects of the proposed Order are as follows:-

- (1) To empower the Authority to dispose of land which is no longer required for the purposes of Montrose Harbour;
- (2) To empower the Authority to pay their members such remuneration, allowances and expenses as they see fit;
- (3) To authorise dredging (the new provision replaces an outmoded existing power);
- (4) To authorise charges for certain floating articles, services and facilities;
- (5) To extend the power of the Authority to licence works contained in article 11 of the Montrose Harbour Revision Order 1991;
- (6) To amend the Schedule to the 1991 Order by inserting a power for the Authority to appoint committees and a provision that the proceedings of the Authority or of any committee shall not be invalidated by any vacancy or defect in an appointment (the new provision replaces an archaic

provision to the same effect);

- (7) To amend certain provisions of the Montrose Harbour Acts and Orders 1837 to 1961 and, in particular, to increase the maximum fines which may be imposed for certain offences under those provisions and to repeal certain obsolete provisions of those Acts and Orders.

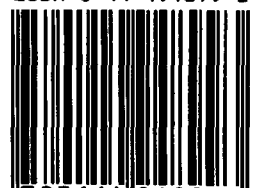
