Reference to the Monopolies and Mergers Commission
Residential Mortgage Valuations

THE DIRECTOR GENERAL OF FAIR TRADING, in exercise of his powers under sections 47 (1) and (2), 49 (1) and 50 (1) of the Fair Trading Act 1973 ("the Act"), hereby refers to the Monopolies and Mergers Commission the matter of the existence or possible existence of a monopoly situation in relation to the supply in the United Kingdom of services consisting of the lending of money on the security of any residential property.

The Commission shall investigate and report on the question whether a monopoly situation exists in relation to such supply and, if so:

- (a) by virtue of which provisions of sections 6 to 8 of the Act that monopoly situation is to be taken to exist;
- (b) in favour of what person or persons that monopoly situation exists;
- (c) whether any steps (by way of uncompetitive practices or otherwise) are being taken by that person or those persons for the purpose of exploiting or maintaining the monopoly situation and, if so, by what uncompetitive practices or in what other way;

- (d) whether any action or omission on the part of that person or those persons is attributable to the existence of the monopoly situation and, if so, what action or omission and in what way it is so attributable; and
- (e) whether any facts found by the Commission in pursuance of their investigations under the preceding provisions of this paragraph operate, or may be expected to operate, against the public interest.

The Commission shall, in investigation and reporting upon this reference, limit consideration to agreements and practices relating to the making or procuring of mortgage valuations and the making of charges, including administration or other charges, to borrowers in connection with such valuations.

In this reference:

"Mortgage valuation" means a valuation (whether or not contained in a report or survey) of residential property undertaken in connection with an application for a secured loan.

The Commission shall report on this reference within a period ending on 5th February 1994.

The supply of ice cream intended for immediate consumption

THE DIRECTOR GENERAL OF FAIR TRADING in exercise of his powers under sections 47(1), 49(2), 49(3) and 50(1) of the Fair Trading Act 1973 hereby refers to the Monopolies and Mergers Commission the matter of the existence or the possible existence of a monopoly situation in relation to the supply in the United Kingdom otherwise than by retail sale of ice cream intended for immediate consumption.

The Commission shall investigate and report on the questions whether a monopoly situation exists and if so

- (a) by virtue of which provisions of section 6 to 8 of the said Act that monopoly situation is to be taken to exist;
- (b) in favour of what person or persons that monopoly situation exists;
- (c) whether any action or omission on the part of that person or those persons in respect of the matter specified for the purposes of this paragraph operates or may be expected to operate against the public interest.

The matter specified for the purposes of sub-paragraph (c) above is the supply to retailers of refrigerated cabinets on terms which prevent the retailer from using the cabinet to stock for sale ice cream supplied by other suppliers.

For the purposes of this reference "ice cream" includes water ices, ice lollies, frozen yoghurt, and ice cream to which fruit, fruit pulp, fruit puree, fruit juice, chocolate, nuts or any other substance is added, but does not include soft ice cream mix.

The Commission shall report upon this reference not later than 18th January 1994.

GRAMPIAN REGIONAL COUNCIL

HILL STREET, ABERDEEN

GRAMPIAN REGIONAL COUNCIL propose to make "The Grampian Regional Council (Hill Street, Aberdeen) (Prohibition of Driving and Prohibition of Waiting) Order, 19 ", under Sections 1 (1) and 2 and 2 (1) to (4) of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit any person from driving, causing or permitting to be driven any vehicle on that length of Hill Street, Aberdeen, extending from its junction with Skene Square to a point 27 metres or thereby westwards, and to regulate the waiting of vehicles on that length of Hill Street specified in the Schedule to the Order.

Exemptions will permit waiting:-

- (1) for the purposes of picking up or setting down passengers;
- (2) for the purposes of loading or unloading goods;
- (3) where necessary in connection with any building operation or demolition; the removal of any obstruction to traffic; the maintenance of the road or the supply of gas, electricity, water or telegraphic services;
- (4) to enable a vehicle owned by a funeral undertaker, or owner of funeral vehicles to be used for a purpose connected with a funeral, but only on occasions when it cannot conveniently be used for such purpose on any other road;
- (5) by disabled drivers.

Full details of proposals are in the draft Order, which, together with a map showing the length of road affected and a Statement of the Council's Reasons for proposing to make the Order, may be examined during normal office hours in the Roads Department, Woodhill House, Westburn Road, Aberdeen, and at the offices of the Divisional Road Surveyor, St Nicholas House, Broad Street, Aberdeen.

Any person wishing to object to the proposed Order should send details of the grounds for objection in writing to the undersigned by 1st June, 1993. Objections should state the name and address of the objector, the matters to which they relate and the grounds on which they are made.
