#### CONDITIONS

All landings of cattle shall be in accordance with the provisions of the Importation of Animals Order 1977 and with the following provisions of this licence.

- The importer shall give 24 hours advance notification of expected time of arrival to the local DVO. Each consignment of cattle shall be accompanied by a certificate signed by a veterinary inspector of the Department of Agriculture for Northern Ireland giving the description, ear number, sex and age of the cattle to which it relates stating that:-
  - 1.1 the cattle originate from herds which are Officially Brucellosis Free; Officially Tuberculosis Free and Officially Leukosis Free in accordance with Council Directive 64/432/EEC (as amended);
  - 1.2 during the 30 days immediately prior to export all cattle except those for immediate slaughter have passed a comparative intradermal tuberculin test carried out in accordance with the provisions of Annex B of Directive 64/432/EEC;
  - 1.3 during the 30 days immediately prior to export all cattle, other than steers castrated not less than one month prior to export, and cattle for immediate slaughter were subjected to the serum agglutination test for brucellosis (B.abortus antigen) with negative results (negative is a titre of less than 30 iu/ml);
  - 1.4 since consignment from their premises of origin the cattle have been kept separate from cattle that do not meet the conditions 1.1 to 1. 3 above;
  - 1. 5 the cattle were examined by him at the time of shipment to Great Britain and showed no evidence of infectious or contagious disease, including warble fly, and were fit to travel. They have been kept separate from animals not so certified.
- 2. Enzootic Bovine Leukosis (EBL) Attested Herds Scheme

A separate certificate, also signed by a veterinary officer

of the Department of Agriculture for Northern Ireland, must be provided for animals originating in herds which are members of the Department's voluntary EBL attested herds scheme. The certificate, which must accompany the animals to their final destination, should confirm membership of the scheme and specify the status of the animals as either "attested" or "once attested". Cattle certified as coming from herds in the scheme must at all times be kept separate from those not similarly certified.

- 3. Shipment must be direct from Northern Ireland to Great Britain.
- 4. The cattle, having landed at the port, shall immediately be taken to their final destination.
- Within 48 hours of arrival at the destination the local DVO should be informed of arrival.
- The appropriate health certification should accompany the consignment to its final destination and be retained for a minimum period of 12 months for presentation to an inspector on request.


