A725 EAST KILBRIDE EXPRESSWAY (HAMILTON ROAD) AND THE WHIRLIES BYPASS, EAST KILBRIDGE

Proposed 50mph Speed Limit

THE STRATHCLYDE REGIONAL COUNCIL propose to consider the introduction of a Speed Limit Order extending the existing 50 mph speed limit restriction on Hamilton Road, East Kilbride from a point 396 metres northeastwards of the Whirlies Roundabout northeastwards for a distance of 179 metres. In addition, it is proposed to introduce a 50mph speed limit restriction on the Whirlies Bypass, presently under construction, over its entire length and, on the A725 East Kilbride Expressway from its new junction with the Whirlies Bypass eastwards for a distance of 605 metres.
