The intention of the Regulations is to ban the import into the UK, storage and supply to the UK Market of CFC, HCFC and HFC

refrigerants in non-refillable (disposable) containers, except for the purposes of research and development or analysis. Regulations to ban the supply of refrigerants in these containers are needed because their use can lead to unnecessary pollution, particularly emissions of ozone depleting substances.
