MISUSE OF DRUGS ACT 1971 - SECTION 12

DIRECTION PROHIBITING EXERCISE OF POWERS IN

RELATION TO CONTROLLED DRUGS

PARESH SAMANI

IN accordance with Section 12(4) of the Misuse of Drugs Act 1971, Notice is hereby given that the Secretary of State gave the following direction which came into force on 11th August 1993.

"Whereas Paresh Samani MPS, a pharmacist within the meaning of the Misuse of Drugs Act 1971, whose registered premises are at 56 Salisbury Road, London NW6 6NN, was on 1st April 1993 convicted of an offence under that Act.

Now, therefore, in pursuance of Section 12(2) of the Act, I hereby direct that the said Paresh Samani be prohibited from having in his possession, manufacturing, compounding and supplying and from supervising and controlling the manufacture, compounding and supply of any controlled drug within the meaning of the Misuse of Drugs Act 1971 which was on 1st April 1993 such a controlled drug save and except the following:

any preparation specified in Schedule 5 to the Misuse of Drugs Regulations 1985, other than any such preparation containing dihydrocodeine or codeine which is a prescription only medicine.

This direction does not extend to the doing of anything in circumstances in which it might lawfully be done without being a pharmacist."

 - (d) At the Rose Street Multi-Storey Car Park the charge for up to 1 hour for Level 1 will be 50p, and in the Multi-Storey Levels 2-10 and Rainings Stairs Car Parks the charges for up to 5 hours, 10 hours and 24 hours (per day) will be 60p, £1.00 and £1.50 respectively.

Off-Street Car Parking in Fort William

- (a) For up to 2 hours parking in Viewforth, Tweeddale, North Service Parade Gardens Car Parks the charge will be 40p.
 - (b) For up to 10 hours in West End, Station and Transport Centre Car Parks the charge will be £1.00.

For monthly tickets the charge will be £15.50 in all car parks.

For the contract parking bays in all locations where these are provided, the annual charge in Inverness will be $\pounds 270$ and in Fort William the half-year charge (from May to October) will be $\pounds 135$.

All other charges will remain the same.


