PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

**NOTICE OF THE ISSUE OF A SUBMARINE PIPELINE
WORKS AUTHORISATION**

THE SECRETARY OF STATE FOR TRADE AND INDUSTRY hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Shell UK Limited, whose address is Shell Mex House, Strand, London WC2R 0DX for the construction of a 10 inch pipe-line and an 8 inch pipe-line at Brent Alpha Platform.

Except with the consent of the Secretary of State, the 10 inch pipe-line shall only be used to convey crude oil and hydrocarbon gas and the 8 inch pipe-line shall only be used to convey water, scale inhibitor and corrosion inhibitor.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Shell UK Limited has been appointed operator of the pipe-lines.
