THE Minister of Agriculture, Fisheries and Food and the Secretary of State, being Ministers designated (a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the Economic Community, acting jointly, in exercise of the powers conferred on them by the said section 2(2), hereby make the following Regulations:

THE ANIMALS AND ANIMAL PRODUCTS (IMPORT AND EXPORT) (AMENDMENT) REGULATIONS 1993.
 S.I. 1993 No. 1967.

These Regulations amend the Animals and Animal Products (Import

and Export) Regulations 1992 by replacing Schedules 1,2,3,4 and 6 to those Regulations. Amongst other changes, they implement Article 17 of Council Directive 92/118/EEC laying down animal health and public health requirements governing trade in and imports into the Community of products not subject to the said requirements laid down in specific Community rules referred to in Annex A(I) to Directive 89/662/EEC and, as regards pathogens, to Directive 90/425/EEC(OJ No.L62, 15.3.1993, p.49).

THE TUBERCULOSIS (DEER) (AMENDMENT) ORDER
 1993 S.I. 1993 No. 2010.

This Order amends the Tuberculosis (Deer) Order 1989 (S.I. 1989/878) so as to remove the general requirement for making or identifying deer on a deer farm. Marking is now required for deer carcasses (other than wild deer) and live deer which are to be moved on or off premises, and deer which are to be tested for tuberculosis.
