THE (A7) EDINBURGH-CARLISLE TRUNK ROAD

BINKS-CASTLEWEARY DIVERSION

NOTICE is hereby given the Secretary of State proposes to make the following two orders under sections 5(2) and 12(1) respectively of the Roads (Scotland) Act 1984:

1. The (A7) Edinburgh-Carlisle Trunk Road (Binks-Castleweary Diversion) Order 199 to provide for the construction of new lengths of trunk road between Binks and Castleweary in the District of Roxburgh in Borders Region to form part of the existing Edinburgh-Carlisle Trunk Road (A7) and the detrunking of a superseded section of trunk road.
2. The (A7) Edinburgh-Carlisle Trunk Road (Binks-Castleweary Diversion Side Roads) Order 199 to provide for the construction of new lengths of side road; the improvement of certain lengths of existing road; the stopping up of certain lengths of road when the new trunk road is open for the purposes of through traffic; the provision of new means of access; and the stopping up of various means of access when the new means of access have been provided.

An Environmental Statement relative to the proposed improvement was published on 28th April 1994.
