GRAMPIAN REGIONAL COUNCIL has made "The Grampian Regional Council (Mannofield, Cults, Bieldside, Milltimber and Garthdee Area, Aberdeen) (Area III South) (Traffic Management) Order, 1994", under the Road Traffic Regulation Act, 1984.

- 5. by disabled drivers.

The order also provides for one-way systems North Deeside Road (slip road), Cults, Gowan Brae Road, Bieldside, Prospecthill Road, Bieldside, Station Brae, Peterculter, and Kennerty Road, Peterculter.
