

THE A98 TRUNK ROAD (KINTORE)  
(VARIABLE SPEED LIMIT) ORDER 199

THE SECRETARY OF STATE gives notice that he proposes to make the above Order to impose a 20 mph speed limit on that length of School Road, Kintore from a point 12 metres or thereby north of the centreline of Nicol Road in a northerly direction for a distance of 335 metres or thereby.

Full details of the proposals are contained in the Order which, together with a plan showing the length of the road involved and a statement of the Secretary of State's reasons for proposing to make the Order, may be examined during normal office hours at:-

The proposed speed limit Order is experimental and shall expire 18 months after it comes into force. For the most part, the 20 mph speed limit will only be in force during those hours where children from Kintore Primary School are travelling to, and from, school and over the school lunch period (approximately 0840 to 0930; 1215 to 1345; and 1445 to 1545 hours Monday - Friday during school terms), during all of which periods the School Crossing Patrol is on duty.

This speed limit will be in operation when indicated by the signs located at each end of this length of road and at all other times the speed limit will be 30 mph as per the Trunk Roads (Route A98) (Restricted Road) (Kintore) Order 1987.

Any person wishing to object to the proposed Order should send details of the grounds of objection in writing to the Secretary, The Scottish Office Industry Department, New St Andrew's House, St James Centre, Edinburgh EH1 3TG, quoting the reference RTO/G35 by 5th December 1994.

COMPANY DIRECTORS DISQUALIFICATION ACT 1986
