

(3) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

3. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of thirty-seven-fortieths fine silver and threefortieths alloy or millesimal fineness 925 and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following that is to say:-

a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;

b) a variation from the said standard diameter of 0.1 millimetres per coin; and

(c) a variation from the said millesimal fineness of five per mille.

(3) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

NICKEL-BRASS COIN

4. (1) A new coin of nickel-brass of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres and a standard composition of seventy per centum copper, five and one-half per centum nickel and twenty-four and one-half per centum zinc, and being circular in shape.

(2) In the making of the said nickel-brass coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:-

(a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;

(b) a variation from the said standard diameter of 0.1 millimetres per coin; and

(c) a variation from the said standard composition of two per centum copper, three-quarters per centum nickel and two per centum zinc.

(3) The said nickel-brass coin may contain impurities of 0.75 of one per centum.

(4) The said nickel-brass coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

5. The composition of the standard trial plates to be used for determining the justness of the said nickel-brass coin shall be pure copper, pure nickel and pure zinc.

DESIGN FOR THE COINS

6. The design for the said gold, silver and nickel-brass coins shall be as follows:-

For the obverse impression Our effigy with the inscription "ELIZABETH II DEI GRATIA. REGINA F.D." and the words "TWO POUNDS", and for the reverse a stylised representation of a dove as the symbol of peace. The gold coin shall have a plain edge

and in incuse letters the inscription "1945 IN PEACE GOODWILL 1995"; and the silver and nickel-brass coins shall have a graining upon the edge and in incuse letters the same inscription.

7. This Proclamation shall come into force on the twenty-fifth day of November One thousand nine hundred and ninety-four.

Given at Our Court at Buckingham Palace, this twenty-fourth day of November in the year of our Lord One thousand nine hundred and ninety-four and in the forty-third year of Our Reign.

COMPANY DIRECTORS DISQUALIFICATION ACT 1986

In a Summary Application presented to the Sheriff Court at Dumbarton in terms of section 6 of the above Act at the instance of Her Majesty's Secretary of State for Trade and Industry in respect of Ronald Stirling Currie, 4 Dickson Drive, Dumbarton, the court has, on 29th August 1994 ordered, *inter alia*, the following:-

"The Sheriff, on Motion of the Pursuer, there being no objection by or on behalf of the Defender, grants a Disqualification Order under section 6 (1) of the Company Directors Disqualification Act 1986 against Ronald Stirling Currie, 4 Dickson Street, Dumbarton and orders that the said Defender shall not, without leave the Court be a Director of a company, or in any way whether directly or indirectly, be concerned or take part in the promotion, formation or management of a company, for a period of Seven years from this date; Directs that the said Order be registered by the Secretary of State for Trade and Industry; Finds the Defender liable to the Pursuer in the expenses of the action as may subsequently be taxed; Allows an account thereof to be given in and Remits same, when lodged, to the Auditor of Court to tax and to report."
