**THE A1 TRUNK ROAD**

**(EYEMOUTH JUNCTION-BURNMOUTH IMPROVEMENT)**

THE SECRETARY OF STATE hereby gives notice that he proposes to make the following Order:

An Order under section 12(1), as read with sections 70 (1) and 143 (1), of the Roads (Scotland) Act 1984, to provide for the construction of a new side road and the improvement of an existing side road to form a new and improved connection to the trunk road; the stopping up of an existing side road; the stopping up of two private means of access and the provision of a certain new means of access.
