SI 1995 No 12

THE BOVINE ANIMALS (RECORDS, IDENTIFICATION AND MOVEMENT) ORDER 1995

This Order replaces the Movement of Animals (Records) Order 1960 (so far as it relates to bovine animals), the Bovine Animals (Identification, Marking and Breeding Records) Order 1990, both as amended, and certain provisions of the Welfare of Animals at Markets Order 1990.

It implements provisions of Council Directive 92/102/EEC on the identification and registration of animals (O.J. No L 355, 5.12.92, p.32) to the extent that it applies to bovine animals.

The principal requirements of the Order are as follows -

- Owners and persons in charge of bovine animals on a holding are required to give information about the holding to the appropriate Divisional Veterinary Officer (article 4).
- (2) Owners and persons in charge of bovine animals are also required to keep records of births, deaths and movement of bovine animals and to keep a record of their numbers (article 5). Article 7 specifies the periods for which these records are to be kept.
- (3) Market operators are required to keep records of calves passing through the market (article 6). Article 7 also specifies the period for which these records are to be kept.
- (4) Owners and persons in charge of bovine animals are to ensure that they are identified by ear tags containing specified particulars (article 8). Tags must be of a pattern approved by the Minister of Agriculture, Fisheries and Food and must not adversely affect the well-being of the

animal (article 13). Lost or illegible ear tags are to be replaced (article 9). They may be removed only on the authority of a veterinary inspector (article 12) and may not be altered or defaced (article 14).

(5) Animals without an identification may not be moved (article 15).

Contravention of the Order is an offence under the Animal Health Act 1981 punishable under section 75 of that Act.

SI 1995 No 11

THE PIGS (RECORDS, IDENTIFICATION AND MOVE-MENT) ORDER 1995

This Order which is made under the Animal Health Act 1981 replaces the Movement and Sale of Pigs Order 1975 and, so far as they relate to pigs, the Movement of Animals (Records) Order 1960 and the Markets, Sales and Lairs Order of 1925. It also implements some of the requirements of Council Directive 92/102/EEC on the identification and registration of animals (O.J. No. L 355, 5.12.92, p.32), so far as they relate to pigs (articles 3(1)(a), 4(1)(a), 4(3), 5(1), and 5(3) of the Directive are relevant).

The principal provisions of the Order are as follows:-

- Each owner or keeper of pigs must supply information to the local Divisional Veterinary Officer about the holding and notify them of any changes in that information (article 3).
- A record of pig movements must be kept (in the form set out in Schedule 1 to the Order) and retained for 3

- years. This record must include details of the identification marks of the pigs concerned (article 4).
- 3. All pigs which are moved must be marked with an identification mark. This may be either a temporary mark or a permanent tattoo or ear tag. Pigs to be exported must be marked by a permanent tattoo or ear tag identifying the holding on which the mark was applied, a distinctive number allotted to the pig and the country code (UK). Pigs moved between holdings in Great Britain must be marked either as if for export or with a mark sufficient to identify them during the journey (articles 5 and 6).
- There is a prohibition on movement of pigs (other than slaughter pigs) between markets and collecting centres (article 7).
- 5. Pigs may only be moved from a farm for certain purposes or returned to it if they are accompanied by a declaration made by the owner (article 9 and Schedules 2, 3 and 4). It is prohibited to move any pigs off premises within 20 days of the movement of any pigs onto those premises. This prohibition does not apply in the case of a number of exempted movements (article 8).
- 6. Pigs may be moved from premises where waste food is kept only if they are accompanied by a declaration made by the owner or keeper and may be moved only to other premises in the same occupation or to a slaughterhouse for slaughter (article 10 and Schedule 5).
- Movement of pigs from a collecting centre is permitted if they are accompanied by a declaration (article 11 and Schedule 6).
- 8. Movement of pigs from any other place is subject to licensing. Such licences are issued by the local authority or an inspector of the Minister (article 12 and Schedule 7).
- Sales of pigs and collecting centres are subject to licensing (articles 13 and 14). Market records are required (article 15). There are detailed provisions relating to licences, declarations and records (article 16).
- 10. The forms of declaration and licence include requirements for cleansing and disinfection with an approved disinfectant of road vehicles used for moving pigs, impose restrictions upon the circumstances in which pigs can be moved in a road vehicle with other categories of pigs or with other things and on the transfer of pigs from one vehicle to another.

Failure to comply with the Order is an offence under the Animal Health Act 1981 punishable under section 75 of that Act (article 19).

The Director General of Electricity Supply (hereafter referred to as "the Director") pursuant to section 11(2) of the Electricity Act 1989 (c.29) (hereafter referred to as "the Act") hereby gives notice as follows:

 In relation to the licence of Scottish Power plc granted under section 6(1)(c) of the act in respect of an authorised area in Scotland (hereafter a "PES licence"), he proposes (subject to the agreement of the Licensee) to make modifications to:

Condition 2 of Part II (Interpretation and construction)

Condition 4 of Part II (Prohibition of cross-subsidies)

Condition 3 of Part V (Prohibition of discrimination)

Condition 2 of Part VI (Basis of charges for top-up and standby supplies or sales of electricity, use of system and connection to system: requirements for transparency)

Condition 2B of Part VI (Requirement to offer terms)

Schedule 6 (Public electricity supply charge restriction conditions)

- The reasons why he proposes to make the modifications and their effect were published by the Director in a statement on 29th September 1994.
- 3. In summary the effect of the modifications will be to amend the relevant Conditions in relation to the year commencing 1st April 1995 and subsequent years by providing for the PES licence:
 - (i) that the Retail Price Index element of the price control formulae for distribution and supply should be calculated on a previous year basis (rather than an estimate of the current year) and averaged over six months;
 - (ii) that X_d means 2;
 - (iii) that X, means 2;
 - (iv) that the supply price control will only apply to customers having a maximum demand not exceeding 100kW and that the provisions as to cross-subsidy and non-discrimination should be modified to reflect this change;
 - (v) that any fossil fuel levy made under section 33 of the Act can be charged to regulated customers;
 - (vi) that the allowed purchase costs will be calculated using a simplified formula;
 - (vii) that the incentive on the Licensee to reduce distribution losses shall be increased by the introduction of a losses term;
 - (viii) that no charge will normally be made for reinforcement of the existing distribution system if the

new or increased load requirement does not exceed 25% of the existing effective capacity on the system, and that the calculation of connection charges shall not generally take into account system reinforcement carried out at more than one voltage level above the voltage of connection:

- (ix) that the requirements on the Licensee to publish charges for special metering or telemetry for settlement purposes is removed;
- (x) that the conditions relating to the provision of information to the Director will be revised;
- (xi) that the date on which the Licensee can next require a review of the supply price control provisions should be 31st March 1998;
- (xii) that the date on which the Licensee can next require a review of the distribution price control provisions should be 31st March 2000; and
- (xiii) that predetermined values are set for certain of the components of $P_{\rm sh}$ and S.

These predetermined values are based on fixed sums of money and estimated numbers of customers.
