PROPOSED PROHIBITION OF DRIVING RESTRICTIONS

THE STRATHCLYDE REGIONAL COUNCIL propose to consider the introduction of a Traffic Regulation Order imposing a road closure (prohibition of driving restriction, except pedal cycles) in West Road, Irvine to the north of its junction with the access road to a bank car park. In conjunction with this measure it is proposed to open, to vehicular traffic, the presently closed section of West Road, to the south of its junction with the access road to a bank car park.
