THE CENTRAL REGION (MAIN STREET, STENHOUSEMUIR) (PROHIBITION OF WAITING) (AMENDMENT) ORDER 1995

THE CENTRAL REGION (WATERSLAP ROAD, WEBSTER AVENUE, MAIN STREET AND QUARROLHALL CRESCENT, CARRONSHORE) (PROHIBITION OF WAITING) (AMENDMENT) ORDER 1995

THE CENTRAL REGIONAL COUNCIL propose to make an Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 which will extend the (No Waiting restrictions on the northwest side of Waterslap Road, Carronshore known locally as Carronshore Road) detailed in the Schedule.

Road in Larbert/Stenhousemuir

Side and Section of Road on Which Waiting is Prohibited At Any Time

Main Street

On the south side thereof from the east kerbline of Muirfield Road in an easterly direction for a distance of 116 metres or thereby.

Note:- Restriction is at the rear of the bus lay-by.

On the north side thereof from the projected east kerbline of Muirfield Road in an easterly direction for a distance of 111 metres or thereby.

SCHEDULE

Roads in Carronshore

Side and Section of Road on Which Waiting is Prohibited At Any Time

Waterslap Road (known locally as Carronshore Road)

On the northwest side thereof from the projected south kerbline of Webster Avenue in southwesterly direction to its junction with Blackmill Crescent, a distance of 101 metres thereby.

NOTE: Restriction will apply to bus layby but not to parking area to rear of layby.
