NOTICE OF THE ISSUE OF A SUBMARINE PIPE-LINE WORKS AUTHORISATION

Except with the consent of the Secretary of State, the 150mm pipe-line shall only be used to convey hydrocarbon gas and oil and the chemical injection umbilical shall only be used to convey wax, corrosion and hydrate inhibitors.

BRIDGE OF DON, ABERDEEN - TRAFFIC MANAGEMENT REVIEW

THE GRAMPIAN REGIONAL COUNCIL propose to make "The Grampian Regional Council (Bridge of Don Area, Aberdeen) (Area VII North) (Traffic Management) Order 1995" under the Road Traffic Regulation 1984.

The effect of the Order will be to introduce waiting restrictions on certain lengths of the roads listed in the schedule below.
