SCHEDULE 1

Road over which means of exercise of public right of passage is to be redetermined –

Alteration from footway to cycle track:

MURRAYBURN DRIVE:

The section of footway on the southern side of Murrayburn Drive commencing at a point opposite St John Ogilvie Church at the junction with the remote footpath from The Greenway and extending north-westwards for a distance of 72 metres or thereby to a point where the route turns and becomes a remote footpath extending westwards for a further distance of 108 metres or thereby leading under Wester Hailes Road to a point on the remote footpath on the west side of Wester Hailes Road at the junction with the pedestrian access to Wester Hailes Education Centre.

SCHEDULE 2

Roads over which means of exercise of public right of passage is to be redetermined - Alteration from footpaths to cycle tracks:-

I. WESTER HAILES ROAD:

The section of remote footpath on the western side of Wester Hailes Road commencing at the southern kerbline of Murrayburn Drive and extending southwards and then south-eastwards for a distance of 190 metres or thereby to a point on the north-eastern corner of the kerbline for the former service road for Westburn Gardens.

II. THE GREENWAY:

The Greenway, commencing on the north-western kerbline of Lanark Road at a point opposite its junction with Hailes Gardens in six sections, in northwesterly then westerly, north-westerly, northerly, north-easterly, northerly and easterly directions for an overall distance of 2380 metres or thereby to a point on the kerbline of Dumbryden Gardens between houses number 45 and 46.

- (a) from the junction of footpaths north-east of 47 Clovenstone Park to the junction of paths at the northern entrance of Clovenstone Primary School;
- (b) from the junction of footpaths 56 metres or thereby north-west of the north-west kerbline of Clovenstone Road to the junction of footpaths 160 metres or thereby north-west of the north-west kerbline of Clovenstone Road:
- (c) from the junction of footpaths, south-east of 21 Murrayburn Place. 86 metres or thereby south-west of the southern kerbline of Hailesland Road to a point on The Greenway 45 metres or thereby south-west of the southern kerbline of Hailesland Road, east of 23 Murrayburn Place;
- (d) from the junction of footpaths north of 23 Hailesland Gardens to a point north of 5 Hailesland Gardens, 48 metres or thereby west of the western kerbline of Hailesland Road;
- (e) from the junction of footpaths 15 metres or thereby east of the eastern kerbline of Hailesland Road, south of

8 Dumbryden Gardens, to the junction of footpaths south of 26 Dumbryden Gardens.

III. UNNAMED SPURS FROM THE GREENWAY:

- (a) The spur from The Greenway to Wester Hailes Shopping Centre commencing 15 metres or thereby south-east of the eastern corner of 4 Murrayburn Place and extending north-westwards, then westwards over Murrayburn Gate for a distance of 140 metres or thereby to the eastern pedestrian entrance to the Shopping Centre;
- (b) the spur from The Greenway commencing at the junction of paths north-west of 5 Hailesland Gardens, 30 metres or thereby west of the western kerbline of Hailesland Road and extending south-eastwards then eastwards over Hailesland Road for a distance of 170 metres or thereby to a point on Dumbryden Drive 28 metres or thereby north of the north-west corner of 4 Dumbryden Grove, together with the path on the eastern side of Hailesland Road bordering Dumbryden Primary School and extending northwards for a distance of 95 metres or thereby between the two footbridges and the path on the western side of Hailesland Road bordering on public open space and extending for a distance of 85 metres or thereby between the two footbridges;
- (c) the spur from The Greenway commencing 20 metres or thereby south of the south-west corner of 8 Dumbryden Gardens and extending northwards for a distance of 100 metres or thereby to the southern kerbline of Murrayburn Road;
- (d) the spur from The Greenway commencing at a point 35 metres or thereby east of the north-east corner of 23 Murrayburn Place and extending westwards for a distance of 280 metres or thereby under Murrayburn Road to a point on the southern footway of Murrayburn Drive opposite St John Ogilvie Church, together with the footpath from the southern footway in Hailesland Road north of 23 Murrayburn Place extending southwards for a distance of 24 metres or thereby.

IV. UNNAMED FOOTPATH NEAR DUMBRYDEN ROAD:

The unnamed footpath commencing at a point on the western kerbline of Dumbryden Road opposite the access to the Union Canal towpath and extending south-westwards and then westwards for a distance of 108 metres or thereby to a point on the eastern kerbline of Hailesland Park 22 metres or thereby south-east of the extended line of the kerbline along the southern and eastern sides of Dumbryden Drive.

EXPLANATORY NOTE:-

The means of exercise of public right of passage on a cycle track is by pedal cycle and foot.
