

This Order will impose a 30mph Speed Limit on that length of road known as Laxdale Lane from its junction with the A857 to a point 50 metres west of its junction with the Guersshader road, together with 50 metres of the Guersshader road from its junction with Laxdale Lane, an overall length of 450 metres or thereby.

Full details of the proposals are contained in the draft Order which, together with a plan showing the lengths of road affected and a statement of the Council's reasons for proposing to make the Order may be examined during normal office hours, Monday to Friday inclusive, at the Council Offices, Sandwick Road, Stornoway.

Any person wishing to object to the proposed Order should send details of the grounds of objection in writing to the Director of Administration and Legal Services, Council Offices, Sandwick Road, Stornoway within 28 days of the date of this Notice.
