TREE PRESERVATION ORDER NO. 1

THE ABERDEENSHIRE COUNCIL (South Division) hereby give notice that in order to retain and protect the special character of the former policy woodlands at Inchmarlo House they have made a Tree Preservation Order in exercise of the powers conferred upon them by the above Act and Regulations with respect to certain trees growing in the area of Aberdeenshire described in Schedule 1 above.

Certified copies of the Order together with the Map executed as relative thereto have been deposited at the offices of the Planning and Economic Development Service, Viewmount, Arduthie Road, Stonehaven and the Banchory Area Office, The Square, Banchory. AB31 3RB for inspection by members of the public during normal opening hours.

Any objection or representation with respect to the Order must be in accordance with Regulation 7 of the above Regulations of 1975 as amended, the terms of which are set out in Schedule 2 below, and be lodged in writing with the Head of Law and Administration (South), Viewmount, Arduthie Road, Stonehaven.
