THE HIGHLAND COUNCIL, in exercise of their powers under Sections 32, 33 and 35 of the Road Traffic Regulation Act 1984, and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

PART I
GENERAL1. *Citation and Commencement*

This Order may be cited as "The Highland Council (Meadow Lane, Thurso) (Off-Street Parking Place) Order 1997", and shall come into operation on 21st July 1997.

2. *Interpretation*

(a) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby assigned to them:-

"Council" means The Highland Council;

"driver" means the person driving the vehicle at the time it was left in the parking place;

"light goods vehicle" means a motor vehicle of unladen weight not exceeding 30 cwt which is constructed or adapted for use for the carriage of goods or burden of any description but for the purposes of this Order is not drawing a trailer;

"parking bay" means a space in the parking place which is provided for the leaving of a vehicle;

"parking place" means the area which is described as a parking place by Article 3 of this Order;

"passenger vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) constructed solely for the carriage of persons and their effects and adapted to carry not more than twelve passengers exclusive of the driver and which is not drawing a trailer;

"permitted hours" means two hours maximum stay;
 "telecommunications equipment" has the same meaning as in the Telecommunications Act 1984;
 "Traffic Warden" has the same meaning as that conferred by Section 95 of the Road Traffic Regulation Act 1984;

- (b) Any reference in this Order to any enactment shall be construed as reference to that enactment as amended by any subsequent enactment.
- (c) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

PART II

USE OF PARKING PLACE

3. *Application of Order to Parking Place*

The provisions of this Order shall apply to the area which is described as a parking place in the Schedule to this Order.

4. *Number Situation and Use of Parking Bays*

The number of parking bays in the parking place shall be as may be determined by the Council.

5. *Limit of Parking Bays*

The limits of any parking bay in the parking place shall be indicated in such manner as the Council may determine by lines, studs or other indications.

6. *Vehicles for which the Parking Place is Designated.*

The parking place described in the Schedule to this Order may be used subject to the provisions of this Order for the leaving, during the permitted hours, of passenger vehicles and light goods vehicles.

7. *Maximum Period of Waiting*

No person shall cause or permit any vehicle to wait in the parking place described in the Schedule to this Order for longer than two hours continuously, or to return to the parking place within one hour of the expiry of a two hour stay.

8. *Use of Vehicles in the Parking Place*

- (a) No person shall, without the prior written permission of the Council, use a vehicle while it is in the parking place, in connection with the sale or distribution of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or service or in connection with the dissemination of information or for party political purposes.
- (b) No person shall use a vehicle while it is in the parking place for the purpose of the hire of the vehicle and no person shall leave, or cause or permit to be left in the parking place any vehicle intended for sale, or on display for sale.
- (c) No person shall leave or cause or permit to be left in the parking place any caravanette, camper, van or other vehicle adapted for sleeping in, between the hours of 8.00pm and 8.00am.
- (d) No person shall load or unload a vehicle while it is in the parking place except for such operations as are necessary for the delivery to and/or collection from adjacent premises of goods, refuse, etc.
- (e) No person shall transfer loads or put loads from one vehicle to another within the parking place.

- (f) No person shall leave an unlicensed or unroadworthy vehicle in the parking place.
- (g) No person shall deposit or store any goods or materials of any description in the parking place.

9. *Repair of Vehicles in the Parking Place*

- (a) No person shall, while a vehicle is in the parking place, permit the carrying out of any work of maintenance or repair thereto except such repair as may be necessary to enable the vehicle to be moved from the parking place.
- (b) No person shall leave a broken down vehicle in the parking place.

10. *Manner of Standing in the Parking Place*

- (a) Every vehicle left in the parking place, except a motor cycle left therein, shall so stand that every part of the vehicle is within the limits of a parking bay.
- (b) The driver of a vehicle using the parking place shall stop all engines as soon as the vehicle is in position in the parking place and shall not start any engines except when about to change the position of the vehicle in or to depart from the parking place.
- (c) No vehicle other than a motor cycle shall be left in the location specified in the parking place for motor cycles.
- (d) No persons shall engage in any activity which creates a disturbance or causes a nuisance in the parking place.

11. *Alteration of Position of Vehicles in the Parking Place*

Where any vehicle is standing in the parking place in contravention of the provisions of Paragraphs (a) and (c) of the last preceding Article, a Police constable in uniform or a Traffic Warden or any other person duly authorised by the Council may move the vehicle or cause it to be moved to a position which shall comply with those provisions.

12. *Removal of Vehicles and Goods from the Parking Place*

Where a Police Constable in uniform or a Traffic Warden or any other person duly authorised by the Council is of the opinion that the provisions of this Order have been contravened or not complied with, in respect of a vehicle or goods left in the parking place, he may remove the vehicle or goods or cause it, or them, to be removed from the parking place and where it, or them, are so removed, shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle or goods. The owner of a vehicle or goods so removed may recover the vehicle or goods on application to the Council and on payment of any expenses incurred by the Council in removing and storing the vehicle or goods.

13. *Moving of Vehicles in the Parking Place in Emergencies*

A Police Constable in uniform or a Traffic Warden or any other person duly authorised by the Council may move or cause to be moved, in case of an emergency, to any place he thinks fit, vehicles left in the parking place.

14. *Manner of Moving Vehicles*

Any person moving or removing a vehicle in accordance with Articles 11, 12 or 13 of this Order may do so by towing or driving the vehicle in or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to move or remove it as aforesaid.

15. *Entry and Exit*

No driver shall cause or permit a vehicle to enter the parking place at a point marked "No Entry" or to leave the parking place at a point marked "No Exit."
