THE CITY OF EDINBURGH COUNCIL

(VARIOUS STREETS, EDINBURGH) (PROHIBITION AND RESTRICTION ON WAITING) (VARIATION NO) ORDER 199
- TO/E/97/46

THE CITY OF EDINBURGH COUNCIL in exercise of their powers under Sections 1(1) and 2 (1) to (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, propose to make an Order the effect of which will vary "The Lothian Regional Council (Various Streets, Edinburgh) (Prohibition and Restriction on Waiting) Order 1978" to the extent of adding the undernoted roads to Schedule 1 of the Order which prohibits waiting at any time.
