THE A86 TRUNK ROAD
 (RUBHA NA MAGACH TO ABERARDER) ORDER 1998

THE SECRETARY OF STATE, hereby gives notice that he has made the above Order in connection with the construction of a length of the A86 Trunk Road between Spean Bridge and Newtonmore lying on the north side of Loch Laggan and more particularly between Rubha na Magach to Aberarder which:-

- (a) Under sections 5(2) to 143(1) of the Roads (Scotland) Act 1984 provides for the construction of lengths of new trunk road and;
- (b) Under section 12(1), as read with Sections 70(1) and 143(1) of the Roads (Scotland) Act 1984 provides for the stopping up of existing trunk road.

Copies of the made Order and relevant plans may be inspected, free of charge, during business hours, from 27th February 1998 to 10th April 1998 at the offices of The Scottish Office Development Department, Victoria Quay, Edinburgh; the offices of Highland Council, Regional Buildings, Glenurquhart Road, Inverness; the offices of Highland Council, Roads & Transport, Market Lane, Kingussie.

Any person aggrieved by this Order, who desires to question the validity thereof, or of any provisions therein on the grounds that it is not within the powers of the Roads (Scotland) Act 1984 or that any requirement of the said Act has not been complied with in relation to the Order may within 6 weeks of 27th February 1998 make application to the Court of Session for the suspension of the operation of, or the quashing of, the Order or any provision contained therein.
