The Director General of Electricity Supply ("the Director") hereby gives notice pursuant to section 11(2) of the Electricity Act 1989 ("the Act") as follows:

- 1. The Director proposes to modify the conditions of the licences granted under section 6(1)(a) of the Act and held by National Power plc, PowerGen plc, Magnox Electric plc, Scottish Nuclear Ltd, Nuclear Electric Ltd and First Hydro Ltd (the "Generators").
- 2. He proposes to modify the conditions of these licences because an obligation not to discriminate unduly between customers, in the supply of electricity to customers in a market within which the supplier is dominant, has been included in the licences granted to suppliers under section 6(2) of the Act.
- 3. In summary, the Director proposes to modify the conditions of these licences granted under section 6(1)(a) of the Act by replacing the condition prohibiting discrimination on all sales of electricity with a new condition which prohibits each Generator from unduly discriminating in the sale of electricity to purchasers other than to final customers requiring a supply of electricity.

- to procure that an offer to enter into the settlement agreement is made to any person who is an appropriate user of the settlement system.
