(DUNDEE SEASHORE - PROHIBITION OF EXCAVATION AND REMOVAL OF MATERIALS) INTERIM ORDER 1999

Notice is hereby given that on Thursday 4th March 1999 Dundee City Council made an Order under Paragraph 15 of the Second Schedule to the Coast Protection Act 1949.

(TEMPORARY PROHIBITIONS) ORDER 1999

On the Fifth day of March Nineteen Hundred and Ninety Nine the East Dunbartonshire Council made the above named order under Section 14(1) of the Road Traffic Regulation Act 1984, as amended, which makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle so as to make a right-hand turn from the northbound carriageway of the A81 Maryhill Road into Rannoch Drive, Bearsden or from the southbound carriageway of the A81, Maryhill Road into the Access Road to Gascube Mill, or from the Access Road to Gascube Mill onto the southbound carriageway of the A81, Maryhill Road. Concurrently, a 30mph speed limit shall be introduced on both carriageways of the A81, Maryhill Road from a point 45 metres west of its junction with the footpath leading to Cluny Drive, Bearsden southeastwards for a distance of 360 metres or thereby to the East Dunbartonshire/Glasgow City boundary, by reason of works proposed to be executed on or near this road.

This Order will operate from 00.01 hours on Monday, 15th March 1999 and will remain in operation until 00.01 hours on Saturday 10th July 1999

Alternative Route:

The alternative route for vehicles which were prohibited from turning right are as undernoted.

Vehicles on the northbound carriageway of the A81, Maryhill Road, prohibited from turning right into Rannoch Drive should travel northwestwards on the A81, Maryhill Road then around Canniesburn Toll Roundabout to the southbound carriageway of the A81, Maryhill Road then proceed southwestwards on the A81, Maryhill Road then turn left into Rannoch Drive.

Vehicles on the southbound carriageway of the A81, Maryhill Road prohibited from turning right into the Access Road to Gascube Mill should travel southeastwards on the A81, Maryhill Road then around the New Acre Road Roundabout to the northbound carriageway of the A81, Maryhill Road then proceed northwestwards on the A81, Maryhill Road then turn left into the Access Road to Gascube Mill.


