PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975 NOTICE OF THE ISSUE OF A SUBMARINE PIPE-LINE WORKS AUTHORISATION

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Burlington Resources (Irish Sea) Limited, whose address is One Canada Square, Canary Wharf, London, E14 5AA, for the construction of two 323.9 mm pipe-lines, three 219.1 mm pipe-lines, a 288.9 mm pipe-line, a 73 mm pipe-line and five chemical injection umbilicals between the Dalton and Millom fields and the North Morecambe field.

Except with the consent of the Secretary of State, the 323.9 mm pipe-lines, the 219.1 mm pipe-lines, and the 288.9 mm pipe-line shall only be used to convey natural gas, the 73 mm pipe-line shall be used only to convey methanol and the chemical injection umbilicals shall only be used to convey methanol and corrosion inhibitors.
