

Stout's Court and extending in a south-easterly direction to a point 6 metres east of the said junction; all of which portions of road are hereinafter referred to as "the restricted roads".

2. (a) The general effect of the Order will be to prohibit any motor vehicle to be driven on the restricted roads, except as listed in Article 3 below;

(b) Prohibit any vehicle to be driven or pedal cycle to be ridden between the portions of road referred to in Articles 1(a) and 1(b) and vice versa;

(c) Prohibit any motor vehicle or pedal cycle to wait on the portions of restricted road referred to in Articles 1(c), 1(d) and 1(e).

3. Exceptions to the restrictions imposed by this Order are permitted in respect of the following:-

(a) Any motor vehicle or pedal cycle used for the sole purpose of taking access to or egress from any property served solely by the restricted roads; and

(b) Any vehicle used for fire brigade purposes or any ambulance or any vehicle in the services of the police force, which are en route to, in attendance at, or departing from an operational incident, or any vehicle in the service of Shetland Islands Council or of any statutory undertaker.

4. Alternative routes for vehicular traffic exist as follows:-

(a) From Church Road to the portion of restricted road referred to in Article 1(b), by way of Church Road, Knab Road, Lovers Loan and Twageos Road; and

(b) From Twageos Road to the portion of restricted road referred to in Article 1(a), by way of Twageos Road, Midgarth Crescent, Lovers Loan, the un-named road linking Lovers Loan and Knab Road, Knab Road and Church Road.

5. The proposed Order shall operate for a six month period.

6. The Council's Director of Environment & Transportation may, if it appears to him essential in the interests of the expeditious, convenient and safe movement of traffic, make modifications of any description (other than additions) to the Order or suspend the Order or any provision of the Order in terms of Section 10(2) of the Road Traffic Regulation Act 1984.

7. A copy of the proposed Order together with the plans showing the lengths of road affected and the Statement of Reasons for making the proposed Order may be inspected at the Legal and Property Services Division, Hayfield House, Hayfield Lane, Lerwick from 9 am to 5 pm, Monday to Thursday and from 9 am to 4 pm on Friday.

#### **THE WEST LOTHIAN COUNCIL (VARIOUS ROADS, WHITBURN) (PROHIBITIONS AND RESTRICTIONS OF WAITING, LOADING AND UNLOADING) (VARIATION) ORDER 199-**

The West Lothian Council in exercise of their powers under sections 1(1), and 2(1) to (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, propose to make an Order the effect of which will be to vary "The Burgh of Whitburn (Various Streets) (Prohibition and Restriction of Waiting) Order 1974". This will have the effect of extending the present restrictions to prevent waiting and unloading adjacent to the newly constructed traffic islands in West Main Street, Whitburn, Limited Waiting bays will be introduced to compensate for the loss of present parking areas. In addition "The West Lothian Council (U27, Loganlea to Addiewell road over Skeliebun Bridge) (17 Tonne Weight Restriction) Order 1997" will be varied to correct a technical error in the original text.
