ABERDEEN CITY COUNCIL - USE OF BUS LANES BY TAXIS

**EXPERIMENTAL ORDER** 

Aberdeen City Council proposes to make "The Aberdeen City Council (Union Street, King Street and Lang Stacht, Aberdeen)

(Peak Hours Bus Lanes) (Amendment) (Experimental) Order 1999" under the Road Traffic Regulation Act 1984.

The effect of the order will be to allow taxis (no private hire vehicles) to use the bus lanes on Union Street, King Street and Lang Stracht for an experimental period of one year. The use of the bus lanes by taxis will be monitored during the trial period and the arrangements will be made permanent, or not, depending on whether the trial results are favourable or unfavourable. Taxis not plying for trade should have their roof signs removed and, in terms of this experiment, should not be using a bus lane. Also, a taxi not carrying any paying passenger should still not enter a bus lane. Full debts of the proposals, are to be found in the draft order, which, together with maps showing the intended measures, and an accompanying statement of the Council's reasons for promoting them, may be examined during normal office hours on weekdays between Monday 29th March 1999 and Monday 19th April 1999, in the offices of the Council's Roads Section on the second floor of St. Nicholas House, Broad Street, Aberdeen. Since the practical import of the order is fairly well clear from what is outlined above,

queries may tend towards the legal and procedural side of things, and these may be directed to Mr. David Wemyss in the Department of Legal and Corporate Services in the Town House - telephone 522523.

Anyone wishing to object to the proposed order should send details of the grounds for objection in writing to the undersigned during the statutory objection period which also runs from 29th March until 19th April inclusive. Any objection should state (1) the name and address of the objector, (2) the matters to which it relates, and (3) the grounds on which it is being made.

#### SPADEMILL ROAD/QUEENS ROAD -

#### TRAFFIC MANAGEMENT

Aberdeen City Council has made "The Aberdeen City Council (Spademill Road/Queens Road, Aberdeen) (Traffic Management) Order 1999" under the Road Traffic Regulation Act 1984.
