#### THE A77 TRUNK ROAD (BANKFIELD TO HOLMSTON ROUNDAABOUTS) (PROHIBITION OF SPECIFIED TURNS) ORDER 199

The Secretary of State gives notice that he proposes to make the above Order which will prohibit right turns from and onto the A77 Trunk Road between Bankfield Roundabout and Holmston Roundabout.

The alternative routes are:

a. Traffic wishing to make a right turn from the A77 Trunk Road should proceed to either Bankfield Roundabout or Holmston Roundabout, circle the roundabout, then proceed along the Trunk Road and make a left turn into the relevant access or lay-by.
