ROADS (SCOTLAND) ACT 1984

THE A7 TRUNK ROAD (HAWICK TRAFFIC RELIEF SCHEME) (REDETERMINATION OF MEANS OF PUBLIC EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER

1999

Notice is hereby given that The Secretary of State has made an Order under sections 2(1) and 152(2) of the Roads (Scotland) Act 1984, redetermining the means of exercise of the Public right of Passage over the road, described in the Schedule hereto.

The title of this Order is "The A7 Trunk Road (Hawick Traffic Relief Scheme) (Redetermination of Means of Public Exercise of Public Right of Passage) Order 1999".

A copy of the made Order and of the accompanying plan showing the road over which the means of exercise of the public right of passage is to be redetermined, have been deposited at the offices of The Scottish Office Development Department, Victoria Quay, Edinburgh, Scottish Borders Council, Headquarters, Newtown St Boswells, Melrose; Scottish Borders Council, Hawick Office, 44 High Street and Hawick Library, North Bridge Street, Hawick. Those documents are available for inspection, free of charge, during business hours, from 28th May 1999 until 9th July 1999.

Any person aggrieved by these Orders, who desires to question the validity thereof, or of any provision therein on the grounds that they are not within the powers of the Roads (Scotland) Act 1984 or that any requirement of the said Act has not been complied with in relation to the Orders may within 6 weeks of 28th May 1999 make application to the Court of Session for the suspension of the operation of, or the quashing of, the Orders or any provision contained therein.

SCHEDULE

1. That length of the existing A7 shall become a footpath and cycle track, the right of passage being exercisable on pedal cycle and foot only, from a point on Dovemount Place, 86 metres or thereby, south west of the Teviotdale Leisure Centre, in a generally southerly direction for a distance of 39 metres or thereby.

2. That length of the existing A7 shall become a footpath and cycle track, the right of passage being exercise on pedal cycle and foot only, from a point on North Bridge 60 metres or thereby, north west of the Teviotdale Leisure Centre, in a generally northerly direction for a distance of 34 metres or thereby.
